Certain Insurance Limits Have Been Revised

The MCMUA is pleased to announce that it has been able to secure a reduction in the general aggregate insurance required for customers with vehicles over 26,000 lbs. Over the past year the MCMUA has been working hard to make sure each of its customers' insurance certificates were in compliance with MCMUA and County of Morris requirements. During this effort the MCMUA received a great deal of feedback from its customers. Based on this feedback and discussions with Morris County's Risk Management Department, the MCMUA is please to announce that it is now able to lower the general liability aggregate limit from \$3 million aggregate to \$2 million aggregate for customers with vehicles over 26,000. All other insurance requirements and limits will remain the same. A summary of these requirements is provided below.

Insurance limits have been reduced to \$2 million for general liability aggregate insurance for haulers with vehicles over 26,000 lbs.

It is important for the MCMUA to have current and compliant insurance certificates and forms in its procession for each of its customers. Failure to keep your insurance documentation current with the MCMUA will result in your company being denied access to use the MCMUA transfer stations. Insurance certificates conforming to MCMUA and County of Morris requirements must be submitted to the MCMUA either by:

Please have your insurance carrier put your account number on all insurance certificates and in addition, have your insurance carrier automatically forward renewed insurance certificates directly to the MCMUA as older certificates expire. This will prevent a denial of access to the transfer stations.

Automobile Liability and General Liability Insurance - All vehicles, except private automobiles, accessing the MCMUA transfer stations are required to carry insurance covering the MCMUA and the County of Morris for all claims arising from Owned, Hired and Non-Owned vehicles.

- For vehicles over 26,000 lbs., the general liability limit must not be less than one million dollars (\$1,000,000) per occurrence and two million dollars (\$2,000,000) general aggregate. The automobile liability limit must not be less than a combined single limit per accident of one million dollars (\$1,000,000).
- For contractors operating vehicles under 26,000 lbs., the general liability limit must not be less than three hundred thousand dollars (\$300,000) per occurrence. The automobile liability limit must not be less than a combined single limit per accident of three hundred thousand dollars (\$300,000).

Workers Compensation And Employers Liability Insurance - In accordance with the mandated statutory requirements of the State of New Jersey, employers' liability insurance shall have the following limits (note: self-employed contractors need not carry this coverage):

<u>For Contractors with Vehicles:</u>	<u>Over 26,000 lbs.</u>	<u>Under 26,000 lbs.</u>
• Each Accident	\$1,000,000	\$500,000
• Disease - Each Employee	\$1,000,000	\$500,000
• Disease – Policy Limit	\$1,000,000	\$500,000

Additional Insured Revisions

- The "County of Morris" or the "MCMUA" must be named as "additional insured" on the certificate of insurance.
- The "County of Morris" or the "MCMUA" must be listed as the certificate holder with the address P.O. Box 370, Mendham, NJ 07945-0370.
- **For vehicles over 26,000** The MCMUA must also receive the Additional Insured Endorsement with the "County of Morris" or the "MCMUA" in the left box and the statement "Contractor drop-off of solid waste at transfer station." In the right box. See the example of additional insured endorsement below.

A. Section II — Who Is An Insured is amended to include as an additional insured the person(s) or organization(s) shown in the Schedule, but only with respect to liability for "bodily injury", "property damage" or "personal and advertising injury" caused, in whole or in part, by:

1. Your acts or omissions; or
 2. The acts or omissions of those acting on your behalf,
- in the performance of your ongoing operations for the additional insured(s) at the location(s) designated above.

B. With respect to the insurance afforded to these additional insureds, the following additional exclusions apply:

This insurance does not apply to "bodily injury" or "property damage" occurring after:

1. All work, including materials, parts or equipment furnished in connection with such work, on the project (other than service, maintenance or repairs) to be performed by or on behalf of the additional insured(s) at the location of the covered operations has been completed; or
2. That portion of "your work" out of which the injury or damage arises has been put to its intended use by any person or organization other than another Contractor or Subcontractor engaged in performing operations for a principal as a part of the same project.

Recycling is Mandatory for Specific Materials

Morris County has designated specific materials to be source separated and recycled. This recycling mandate applies to all Morris County waste generators including residents, businesses, schools, institutions, construction sites, etc. A listing of these mandated recyclable materials is provided to the right but please note that this listing is a generalized listing and specific definitions of these materials and any exceptions that may apply is available on the MCMUA's website at: <http://mcmua.com/recycling>.

Please realize that Morris County's source separation recycling mandate is nothing new as these materials for the most part have been mandated to be recycled since 1993 and disposing of designated recyclable materials in the trash is not acceptable and is illegal in Morris County. The MCMUA has been advised that the Morris County Office of Health Management will be inspecting loads and issuing fines for disposing of designated recyclables at the transfer stations.

Materials Mandated to be Source Separated and Recycled

- Aluminum Cans
- Glass Bottles and Jars
- Plastic Bottles (coded 1 and 2)
- Steel (Tin) Cans
- Newspaper
- Corrugated Cardboard
- Mixed Paper
- Leaves
- Grass Clippings
- Brush
- Natural Wood Waste
- Oil Contaminated Soil
- Used Motor Oil
- Lead-Acid Batteries
- Hazardous Dry Cell Batteries
- Metal Appliances
- Whole Tires

Pools Safety Doesn't End at the Pool

In July 2003, and then again in July 2008, fires occurred at the MCMUA's Mount Olive transfer station. In both situations it is believed that small quantities of pool chemicals were improperly disposed of in the regular trash setting off a reaction which in turn caused the fire. The 2003 fire happened in the transfer station building while the more recent 2008 fire happened within a solid waste transfer trailer. If pool chemicals are improperly mixed with wet garbage or other chemicals, reactions and oxidation can begin resulting in fires and the release of toxic fumes. This isn't safe for anyone.

If collecting waste from a home or a business with a pool or a spa, please be aware of the potential dangers of pool chemicals being improperly mixed with the garbage. If collecting dismantled pieces of an old swimming pool, filters, tubing, liners, etc., pay special attention to make sure there are no unwanted pool chemicals in the mix. Ask questions of the pool owner to make sure they have disposed of their pool chemicals correctly and haven't slipped you a potentially dangerous chemical that you may regret.

Fill In the Correct Waste Origin (Town) on the Origin and Destination (O&D) Form.

The MCMUA is requesting that when you complete your O&D form that you take care in completing the section regarding the waste origin, which is the town where the garbage was generated. Many towns share similar names such as Boonton and Boonton Township; Chatham Borough and Chatham Township; Morristown, Morris Township and Morris Plains and; Rockaway Borough and Rockaway Township and the MCMUA requests that you accurately designate your load as being from the correct municipality. In addition, if your load is from multiple origins you should specify all the towns in the load by an estimated percentage as provided on the O&D form. Finally, please realize that many towns share zip codes so you cannot use the zip code of the generator to determine the waste origin. You must consider and know where the actual town boundaries are. As an example, many Rockaway Township, Wharton and Denville addresses use the 07801 Dover zip code.
