On March 18, 2025, the Morris County Municipal Utilities Authority (the “Authority” or “MCMUA”) published a Notice to Bidders requesting bids for “TRANSPORTATION AND DISPOSAL OF ALL SOLID WASTE RECEIVED AT THE SOLID WASTE TRANSFER STATION LOCATED IN MOUNT OLIVE TOWNSHIP.” On April 8, 2025, the MCMUA conducted a site tour of the Transfer Station Facility with potential Bidders.
