On March 18, 2025, the Morris County Municipal Utilities Authority (the “Authority” or “MCMUA”) published a Notice to Bidders requesting bids for “TRANSPORTATION AND DISPOSAL OF ALL SOLID WASTE RECEIVED AT THE SOLID WASTE TRANSFER STATION LOCATED IN PARSIPPANY – TROY HILLS TOWNSHIP.”

The Authority has prepared Addendum #2 in response to written questions received by the Authority, and to clarify certain terms and conditions of the Requests for Bid. Addendum #2 includes:

- Revision to Administrative Documents
 - Removed “Statement of Bidder’s Experience Form - Transportation of Solid Waste”
 - Removed “Experience Statement Form – Disposal Facility Agreement to Provide Disposal Capacity (Contingent Upon Award of Contract)”
 - Added “Agreement to Provide Disposal Capacity Contingent on Award of Contract – Township of Parsippany-Troy Hills Facility (This Agreement is not required to be submitted where the Disposal Facilities proposed in the Bid are directly owned or operated by either the Bidder or an Affiliate of the Bidder.)”
- Removal of “Experience Statement Form Disposal Facility – Township of Parsippany-Troy Hills Facility”
- Title of “Statement of Bidders Experience” has been changed to “Certification of Questionnaire” (Pages 40 to 41 of the Bid Packet)
 - Removed references to “Forms” within the “Certification of Questionnaire”
- Title of “Statement of Bidders Experience” has been removed from “Questionnaire” (Pages 42 to 43 of the Bid Packet)
- Removed from “Questionnaire” #12: List the names and address of three credit or bank references.

Addendum #2 is being sent via overnight delivery and by email to all prospective bidders that have previously received a bid package from the Authority. Pursuant to the Notice to Bidders issued on March 18, 2025, sealed Bids must be received at the offices of the Authority by 11:30 A.M. on May 30, 2025.
